1. Procedure for outdoor medical claim for Serving Employees:-

The Ceiling for outdoor medical claim with voucher in the financial year shall be 15 days [Basic pay + DA]. The rest of the conditions remain the same as mentioned in OM No. BSNL / Admn.1/15-12/18 dated 19.07.2018. The Basic Pay + DA as on 01.04.2020 will be the basic of calculation, until further orders from the BSNL Corporate Office, New Delhi.

2. Retired Employees:-

A. Those retired employees who have already opted for and migrated to CGHS, need not exercise fresh options. They continue to avail the treatment as per the procedure and instructions of CGHS only and those who want to opt for CGHS have to surrender their BSNLMRS Card to collect the surrender certificate from their concerned BSNLMRS Card issuing authority.

B. With Voucher: Limited to 15 days of Basic Pay + DA on the date of retirement.

C. Without Voucher: Flat Rs. 1000/- [Rupees One thousand] Per Month.

D. The retired employee those who are willing to changer their option [either from with voucher to without voucher or from without Voucher to with voucher] with effect from 01-04-2020, may be allowed till 31-08-2020 failing which their earlier option will be continued.


